### **Public Comment**

#### **Grant Updates:**

Jordan Wicks and Alexis Wivell provided a short presentation updating the group on the statis of the Virginia Tech Meat Center and ongoing projects funded through VCIB grants. The Meat Center will host the Beef Up short course on July 27-29, educating students from around the state about different topics pertaining to the local meat industry. Subjects will span from meat cutting, to evaluating carcasses and marketing product. This grant was funded by the VCIB as Grant 23-1B "Building Capacity and Food Security: Expanding the Meat Processing Education in the Commonwealth."

Stephanie Weiss provided an update pertaining to grant 23-5B "*Meet Virginia Cattle Producers* – *Promotional Video*" and grant 23-4B "*Virginia Beef & Cattle Module*." via email. The Board viewed a short you-tube video highlighting the six part series that the Virginia Beef Council developed with support from the VCIB. The video series was aired on television ads around the state as well as a multi-faceted social medial campaign including Facebook, Instagram, and YouTube. Over one million homes were reached through the television ads and over 60,000 impressions were made on social media thus far. The Beef Module is completing design work and set to be installed soon. The Module is on track to be rolled out at the Virginia State Fair.

## **Other Grant Proposal discussion included:**

#### Grant# 24-3 "Optimizing Processing Conditions for High-Quality Tender Beef"

The Board shared concerns that the budgeted \$20 per hour for undergraduate employees was inflated over common part time labor rates. Shelton made a motion to approve the grant at the full amount, allowing up to \$15 per hour in labor charges and not to exceed a total of \$10,000 in total personnel expenses. Huffman 2<sup>nd</sup> and the motion passing unanimously.

### Grant# 24-6: "Southwest Virginia 4-H Education Center 4-H Livestock Camp"

Moyer made a motion to approve the grant request, minus the requested amount of \$1,650 for supplies. Huffman 2<sup>nd</sup> and the motion passed unanimously. The new approved amount for the grant is set at \$4,500. The grant recipients are encouraged to reach out to the Virginia Beef Council for assistance in getting the needed promotional supplies for the program.

### Grant# 24-12: "VCA Internship Program"

Tucker made a motion to deny the grant request in full, citing that it was not in the VCIB's interest to provide funding for an individual organization's labor staff while being provided minimal detail of the work plan and the benefit it would have on the Virginia cattle industry. Huffman 2<sup>nd</sup> and motion passed unanimously.

## Grant# 24-13: "Cattle Producer Education Program Grant"

Smith made a motion to approve the grant while removing the word "written" from the statement "Written report within 2 weeks of event recapping what was learned" under the Eligibility Requirements for the Program section of the request. The Board feels that other types of reporting information could be sufficient and valuable while not discouraging participation from those unwilling to compile a written report. Threewitts 2<sup>nd</sup> and motion passed unanimously.

### Grant# 24-15: "VA Cattle Marketing and Promotion – Ontario Trip"

While supporting the grant request, the Board explored ideas of insuring that different areas of that state were well represented on this promotional trip. McNeil made a motion to approve the grant with the removal of participants being selected on a first-come first-serve basis. Lloyd 2<sup>nd</sup> and the motion passed. It is the Boards desire that the VCA selects 5 representatives from a cross section from the Virginia cattle productions areas.

#### **Other Business**

A request to extend grant 22-4 was made by Dr. Scott Greiner of Virginia Tech. No additional funding was requested, only an extension of the term of agreement. Dr. Greiner informed the group that the management position of the Virginia Beef Cattle Center of Excellence had been filled and he provided a short progress report to bring the Board up to date. McNeil made a motion to extend grant 22-4 through February 28, 2024. Smith 2<sup>nd</sup> and motion passed unanimously.
